- **FAMILY GUYS LLP®**

- Family Guys LLP® is a business entity offering this service 'Local Tourism'. And the Terms and Conditions only apply to the 'Local Tourism'.

- **Who are the clients?**

- Anyone above the age of 18 years (18+) can be our customer under this category. Valid and Not-Expired ID verification required (Provencial photo ID, Drivers Licence, Passport etc.)
- Families (Husband/Wife, Common Law Partners, Guardians) along with kids under 18 years of age. Relationship with kids needs to be verified through the same address (with at least one parent, guardian).
- In case of one parent for less than 18 years of age, legal permission from the other parent, or guardian will be required.
- **MUST - FOR toddlers/Children: Rear-Facing Seats, Forward-Facing Seats, Booster Seats & Seatbelts.**
- For customers 'They/Them' will be used onwards.

- **What we provide?**

We provide the following under this category.

- They will be picked and dropped from/to the address provided.
- They should be healthy (no seasonal illness) and willing to go out for one- or two-day/one night vacation planning.
- In case they use folding walker and or folding wheelchair, only one will be allowed in the back trunk of the vehicle. If there are two clients booked at the same time only one folding walker and or folding wheelchair will be accommodated in the back trunk of the vehicle.
- We cannot accommodate the motorized wheelchair or any other device.
- 1 person is allowed to carry 5kg/11lbs of personal luggage (bag, or sack – no loose or scattered items). For a family of four the allowable weight is only 20kg/44lbs.

- Under Local Tourism they will be provided the following services: pick and drop, vehicle with a driver, hotel room (s), refreshments, meals (breakfast, lunch, dinner), gas and parking.

However, any family member/family friend or legal representative can also book/reserve this service.
- After booking/reservation REFUND will not be made available if the cancellation period is less than 72 hours i.e. if the pick-up time is 10:00 am on June 1 and the cancellation request received (phone, text, WhatsApp or email) at 10:01am on May 29 then the REFUND will not be made available as the cancellation request time is less than 72 hours i.e. 71 hrs and 59 minutes.
